

Pension Application for Zadock Bartlett or Bartlet

W.23483 (Widow: Hannah) Hannah Sever and Zadock Bartlett were married February 1780. Zodack died January 23, 1837.

State of New Hampshire

On this twenty first day of October 1828 personally appears in open court (being a court of record for the State of s'd Newhampshire), Zadock Bartlett aged seventy two years who being first sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the acts of Congress of the 18th March 1818 and the 1st of May 1820 that he the said Zadock Bartell enlisted about the first of May 1775 in the State of Massachusetts in the Company commanded by Captain Samuel Wood in the Regiment commanded by Col. Jonathan Ward in the line of the State of Massachusetts on the Continental establishment that he continued to serve in s'd Corps until the December following when he ws discharged form said service & on the same day entered the company commanded by Capt Daniel Barns of the above named Regiment and served in s'd company until the February following when he was discharged by s'd Barns making ten months uninterrupted service and that he has no other evidence now in his power of his said services except the deposition of Silas Baily & Reuben Babock.

And in pursuant of the act of the 1st May 1820 I do solemnly swear that I was a resident citizen of the United Sttes on the 18th March one thousand eight hundred & eighteen and that I have not since that time by gift sale or in any name dispose of my property or any part thereof with intent thereby doth diminished it as to bring myself within the provisions of an act of Congress entitled. An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war passed on the 18th day of March one thousand eight hundred and eighteen and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other than what is contained in the schedule hereunto annexed and by me subscribed. Declaration, in order to obtain the benefit of the Act of Congress of the 7th of June 1832.

On this Tenth day of August 1832 personally appeared in open Court before the Hon Aaron Matson Judge of Probate for said County, now sitting Zodock Bartlett a resident of Chesterfield in the county of Cheshire and state of New Hampshire aged 76 years last April who, being first duly sworn, according to law, doth on his oath make the following declaration, in order to obtain the benefit of the act of Congress, passed June 7th 1832.

That he entered the service of the United States under the following named officers, and served as herein stated.

1st In 1775 went on the alarm to Cambridge inlisted there for eight months in Capt. Saml Woods Comp'y Col Wards Regt, Mass Troops Genl Wards Brigade, stationed in Cambridge and Dorchester dismissed at the end of the 8 months, in District Dorchester, and the same day volunteered and entered the Company Commanded by Capt Daniel Barnes in the same Regt stationed at Dorchester for five months and at the expiration of the time was dismissed.

1776 In August or Sept inlisted again at Northboro for 2 months were sent for from each town west to Tarrytown N. York joined a company on the way at Skeensboro New Y, stationed there at Tarrytown till my time was out was dismissed there, was at White Plains. Cant recollect the Continental troops retreated from the City of New York.

1777 In Sept a call for men to go to Stillwater & Saratoga volunteered for 3 months served he thinks in Capt Sherman or Morsey Com'y, Col Cushings Regt went to Stillwater was on guard the day of the battle of Stillwater and also of Saratoga. Saw Genl Burgoyne's Army march out saw Genl Burgoyne at Breakfast with Genl Gates Tent stayed till after the prisoners were marched off, and there was marched down towards New York and was dismissed at the end between Albany & New York City.

Born in Northboro Mass in the year 1756 no record except my bible unless one at said Northboro. Lived at said Northboro when I entered the service which one at said Northboro—lived at said Northboro when I entered the service has served at Chesterfield where he now lived since the Revolution. Volunteer in all the service, never rec any discharge in writing. Recollects Genl Washington in his first service—also that Col was near his Regt there—half Regt was ordered on to Bunker hill, recollects that there were out our troops at Tarrytown—no consideration as stated above—that there was a great number of troops at the taking. Rev Elishu Smith at Chesterfield of whose church I am a member and Joab [Witherback?] and I expect can testify to my veracity & their belief of my services.

He hereby relinquishes every claim whatever to a pension or annuity except the present and he declares that his name is not on the Pension Roll of the agency of any State. Zodack Bartlet.
