

## **Pension Application for Isaac Cowan**

County of Rensselaer SS.

On this fifth day of September 1832 personally appeared in open Court before the Judge of the Troy Mayors court now sitting Isaac Cowen a resident of the Town of Stephentown in the County of Rensselaer and State of New York aged seventy five years who being first duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the Act of Congress passed June 7, 1832.

That he entered the service of the United States under the following named officers and served as herein stated.

That he enlisted in the company commanded by Captain Henry B. Livingston of the Regiment commanded by Colonel Holmes, August 7, 1775, at Fredericksburgh in the County of Dutchess of State of New York and marched from there to Albany was there - - - two months, then left that service that he resided at the time of enlisting at Fredericksburgh aforesaid that he enlisted in Captain Corenius Steenrod's Company about the first of April 1776, and marched from Fredericksburgh aforesaid where he then resided to New York and was there - - - one month at the time the Fort was building at Hurlgate, that he enlisted in Captain Cornelius Steenrod's Company of the Regiment commanded by Alexander McDougall the first of May 1776 for eight months and served his time out was stationed at New York bowery marched from Fredericksburgh aforesaid to New York, he resided at Fredericksburgh at the time he enlisted that he enlisted in the company commanded by Lieutenant Thomas Seers June 1777, for two months and served his time out was stationed at Fredericksburgh where he then resided, that he was a substitute in Nathaniel Boynton's place in a company, Captain Elijah Townsend Commander in the Regiment commanded by Colonel Henry Luddington, in July 1777 was stationed at Crum pond and at Peekskill was in that service three months, resided when he entered the service at Fredericksburgh, that he enlisted in Captain Elijah Townsend's Company of the eRegiment commanded by Colonel Henry Luddington May 1<sup>st</sup> 1778 for eight months was discharged the last of November following was stationed at White Plains in Westchester County, resided when he enlisted at Fredericksburgh aforesaid, that he was called out in an alarm in Captain David Waterbury's Company of the Company of the Regiment commanded by Colonel Henry Luddington August or September 1779 to go to Peekskill was out- - - Ten days resided at Fredericksburgh aforesaid that he enlisted in Captain Andrew White's Company of the Regiment commanded by Colonel Frederick Weisenfeltz May 1<sup>st</sup> 1782 for eight months and served his time out was stationed at Wawasing Ulster County during that time at the time of enlisting he resided at Fredericksburgh aforesaid, has had discharges from service in writhing but has not seen any in a number of years, thinks they must be lost does not know of any person whose testimony he can procure that can testify to his service, he hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any state or (if any) only on that of the agency of the State of New York.
