

Pension Application for Isaac Hubbell

County Court.

On the 19th day of July A.D. 1820 Personally appeared in open Court being a Court of record for the said County Isaac Hubbell aged sixty four years a resident of the Town of Weston in said County, who being first duly sworn according to Law doth on his oath Declare that he served in the Revolutionary War as follows, Viz.

That he enlisted on the 17th day of May A.D. 1775 under Capt David Dimon in Col Waterbury's Regiment for seven months when his term of service expired; then enlisted for five months in Capt Albert Chapmans Company under General Wooster and Marched to Quebec and at the expiration of the said five months in May 1776 enlisted under Capt Robert Johnson in Col. Nicholson's Regiment for two years, in the New York line, and in November following enlisted during the War in Capt John Grahams Company in Col Goozer Van Skoyck's Regiment in the New York line and faithfully served until he was taken by the Indians and carried to Quebec where he was held a prisoner three years when he broke prison and made his Escape, returned and joined his Regiment, at a place called Snakes Hill in the State of New York and served until the 3d day of June A.D. 1783 when he was honourably Discharged.

And that he is now on the Pension list under the act of Congress of the 18th of March 1818, and that his Declaration on which he was so placed on said pension list bears date the 31st Day of March 1818 and that his pension certificate is Numbered 10.105.

And I the said Isaac Hubbell do solemnly swear that I was a resident Citizen of the United States on the 18th day of march 1818 and I have not since that time, by sale or in any manner disposed of my property or any part thereof; with intent thereby so to diminish it, as to bring myself [myself] within the provisions of an Act of Congress entitled an Act to provide for persons engaged in the Land & Naval service of the United States in the Revolutionary War passed on the 18th day of March 1818, and that I have not nor has any person for me any properties or securities, contracts or debts due to me, nor have I any income other than what is contained in the Schedule hereunto annexed and by me subscribed.

My business since the war has been that of a day labourer, my health has been so much impaired, that I have not been able to work more than half of the time during the last ten years and that during said time I have received a part of my support from the ;town of Weston afore'd.

I have a wife aged sixty two years and Mabel and she having a lameness (occasioned by a dislocation of the ancle [ankle] joint) which is very injurious to her both with regard to labour and walking, and no other persons in my family all which is subscribed by me. (Signed) Isaac Hubbell

Sworn to and declared in the Court aforesaid—whereupon said court is, on satisfactory proof exhibited in Court of opinion that the total amount in value of the

property contained in the aforesaid schedule is twelve dollars, twenty four cents; and doth order these proceedings to be entered in the records of said court. Attest, David Burr, Clerk
