Pension Application for Gabriel Leverick or Leverich

Marine Court of the City of New York on this nineteenth day of June 1820, personally appeared in open Court, being a Court of Record according to Statute of the State of New York, Gabriel Leverick of the Town of Newtown in the County of Queens and sate aforesaid aged sixty eight years resident in the said district who being first duly sworn according to law, doth on his oath declare that he served in the revolutionary war as follows.

That he the said Gabriel Leverick enlisted for the town of the whole war in the month of April 1777 in the State of Connecticut In the Company of Artillery commanded by Captain Jonathan Brown in the Regiment commanded by Colonel John Lamb in the line of the State of New York on the Continental establishment, that he continued to serve in the sais Corps until about a year and a half of the peace.

And then was transferred to a coprs of Infantry and served the last mentioned period in the Company of Captain Clifts in the Regiment commanded by Colonel Thomas Grovner in the line of the State of Connecticut making the term of service the whole war from April 1777.

Thjat he was in the battle of Fort Montgomery on the North river at the time it was stormed by the British and the said Gabriel Leverick was discharged at the conclusion of the peace.

That he made an original declaration on or about the 27th of April 1818, and that he has accounts in the whole \$178.25/100.

And that the number of his pension certificate is (1779).

And I do solemly [solemnly] swear that I was a resident citizen of the United States on the 18th March 1818 and have not since that time by gift sale, or in any manner disposed of my property or any part thereof with intent thereby so to diminish it as to bring myself within the provisions of an act of congress entitled "an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war" passed on the 18th March 1818 and that I have not nor has any person in trust for me any property or securities contracts or debts due to me nor have I any income other that what is contained In the schedule [schedule] hereunto annexed and by me subscribed.

My real estate consists of a small wooden house, one story high, standing on a part of a piece of ground 80 feet square leased for fifty cents a year, the [?] old and out of repair and was built for me by private charity.

My personal property consists of 3 [?] one half doz chairs, one table a doz knives and forks about a doz spoons, I doz tea cups and saucers. The same no of plates, 1 pair of tongues, 1 shovel, 1 pair of andirons.

My trade that of a Blacksmith now no occupation or ability to persue it.

My family consists of a wife 68 years of age and infirm, 2 daughters & one son. The last of which no capable to contribute to their own support. And further that I the

said Gabriel Leverick am incapable of supporting myself except by private or public charity. (Signed) Gabriel Leverick
