

**Pension Application for Dyonisius Miller**

On this 25<sup>th</sup> day of November 1842, John Miller, administrator of the goods and chattels, lands and tenements of Dionysius Miller late of the town of Canajoharie in the said county of Montgomery deceased personally appeared before the Surrogate court of said county, being a court of record, who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the pension made by the Act of Congress passed 7<sup>th</sup> June 1832.

That the said Dionysius Miller as this applicant has reason to believe, then a resident of the city of New York entered the service of the Unites States at the commencement of the Revolutionary War in the said city of New York as a private under an enlistment for a term of eighteen months that he was in the battle of Long Island (1) in the year 1776. That on the taking possession of said city by the enemy he removed to Montgomery then Tryon county, where he performed several terms of service in the company of Capt. House (2) and Lipe. (3) That he died at Montgomery county aforesaid on the 23d day of March 1834 without ever having received or made application for the benefits of the above mentioned acts of Congress. That he this applicant therefore claiming the amount that would have been due him at the time of his death by reason of his service in the Revolutionary War and on the proof I have hereto annexed he rests his claim. That the reason of not making this application sooner was my ignorant of the claim.

Joseph House in the year 1780 and also in the company of Capt. Adam Lipe in the year 1780 and he further swears that the said Dionysius Miller at the time of his death left him many children named John and Catharine and he also further swears that the said Dionysius Miller often informed him this deponent that he served in the city of New York under an enlistment eighteen months at the commencement of the revolutionary war and that he was in the Battle on Long Island and further he says not.

End Notes—R.7182—Dyonisuis Miller

1. The Battle of Long Island was fought on August 7, 1776. So far Dyonisuis' name has not been found on militia muster rolls for that area and time period.

2. Captain Joseph (Jost) House commanded the Sixth Company in Colonel Samuel Campbell's First Regiment of Tryon County Militia. Captain Abraham Copeman had commanded this company until he was promoted major of the regiment on October 19, 1779. Dyonisuis most likely had also served under his command until Copeman was promoted.

3. Adam Leipe was also a captain in Colonel Campbell's Regiment.

7. On August 2, 1780 the areas now the Village of Fort Plain and the Town of Minden were destroyed in a raid by Captain Joseph Brant. In this raid Dyonisuis wife Eve and daughter Catharina were taken prisoners. On page 77, Volume 6, The Public Papers of George Clinton, First Governor of New York, J.B. Lyon Company, Albany 1902 is the following: "An Exact List of all Persons which were taken by the Indians near Fort Plank."
