## **Pension Application for Ezekiel Mott**

R.7463 (Widow: Jane)

State of Ohio

Portage County SS.

On this twenty second day of April 1818 before me the subscriber one of the Judges of the Court of Common Pleas for the said County personally appeared Ezekiel Mott aged eighty one years resident in Deerfield In the said County who being by me first duly sworn according to law doth on his oath make the following declaration in order to obtain the provision made by the late act of Congress entitled an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary War.

That he the said Ezekiel Mott enlisted for the term of three years on the [blank] day of June in the year 1777 in the State of New York in the company commanded by Captain Coons of the Regiment commanded by Colonel Malcomb in the lien of the State of New York on the Continental establishment that he continued to serve in the said crops or in the service of the United States until the month of June 1780 when he was discharged from service in Pumpton [Pompton?] State of New Jersey.

That he was in the battles of Trenton, Springfield, also at the Battle of Newtown under General Sullivan and that he is in reduced circumstances and stands in need of the assistance of his country for support and that he has no other evidence now in his power of his said services. (Signed with his mark) Ezekiel Mott

Letter in folder dated February 18, 1937, written in response to an inquiry.

Reference is made to your letter in which you request the records of Thomas Healey, of Connecticut, and Ezekiel Mott, of New York, Revolutionary War soldiers and pensioners.

The records of those soldiers follow.

Thomas Healy

The data which follow are obtained from the papers on file in Revolutionary War pension claim, S.15882, based upon the military service in that war of Thomas Healy.

Thomas Healy was born in East Greenwich, Rhode Island, December 9, 1740. The names of his parents are not shown.

While residing in said East Greenwich, Thomas Healy enlisted and served from May 1776 to November 1776, five tours of two weeks each, as a private in Captain Whitmarsh's Company, under Major Thomas Potter in the Rhode Island troops, and acted as a guard for the shores of Narragansett Bay: while residing in South Kingston, Rhode Island, he enlisted in April, 1777, and served four tours of one month each as a private in Captain Samuel Potter's Company, under Major Thomas Potter in the Rhode Island troops; in March, 1778, he moved to Charlestown, Rhode Island, where he was placed in Captain Amos Greens' Company, Colonel Noeys' Rhode Island Regiment and

served on four tours of one month each; during this service he participated in General Sullivan's Rhode Island expedition: from March 1779, he served five months and from March of April, 1780, and one-half months under said Captain Green and Colonel Noyes.

Thomas Healy was allowed pension on his application executed July 31, 1833, while residing in Sterling, Windham County, Connecticut.

There are no data as to soldier's family.

Ezekiel Mott

The data which follow are obtained from the papers on file in Revolutionary War pension claim, R.7463, based upon the military service in that war of Ezekiel Mott.

The date and place of birth and the names of the parents of Ezekiel Mott are not shown.

Ezekiel Mott was in the battle of Trenton, details of this service not given; he enlisted in the state of New York, in June, 1777, served as a private in Captain Evans' (evidently meant for Captain Daniel Niven's) Company, Colonel Malcolm's Continental Regiment, was transferred to Colonel Spencer's Regiment and was discharged in June 1780, at Pompton, New Jersey. He was in the battle of Newton under General Sullivan and in the battle of Springfield.

He was allowed pension on his application executed April 22, 1818, at which time he was aged eighty-one years and resided in Deerfield Township, Portage County, Ohio.

In 1819, son Ezekiel Mott, Junior, made affidavit in Portage County, Ohio, that he was with his father in the army first at Wyoming, at which place his father "left all of his family and went on an expedition to the northward. On his return home, my mother having died in his absence, he took me with his father in the army for at least one year at which time he was aged seven or nine years, that there were five children and that his father received his discharge because of the "largeness of his family." He did not give the names of the other children.

In 1820, the soldier stated that his family then residing with him consisted of his wife, only, her name Jane, aged sixty years. He did not give the date and place of their marriage or her maiden name. Jane Mott died November 16, 1838, in Medina County, Ohio. It was stated that they were married in the state of New Jersey during the Revolution.

Ezekiel Mott the soldier died in Portage County, Ohio, about 1823.

Ezekiel and Jane Mott had a family of children. In 1854, one Elijah Mott made affidavit in Stark County, Ohio, that he was a grandson of Ezekiel and Jane Mott. In same year, one Eunice Carter made affidavit in Stark County, Ohio, that she was the daughter of Elijah Mott, son of the soldier Ezekiel and his wife Jane. No other names of children are given.

In 1854, one George Carter made affidavit in Stark County, Ohio; no relationship to Eunice Carter, granddaughter of the soldier was stated.
