## **Invalid Application for George Stansil**

Private Col. Capt. Cogh's NY Reg't (Klock Colo) U.S. Army

Inscribed on the Roll of the New York Agency at \$3. & increased to \$4.80 by act 24 April 1816. Formal pension Certificate issued May 10th 1824 and sent to Postmaster Freys-Bush, Montgomery County, New York.

We the Subscribers, Abraham Ten Broeck and Philip Schuyler do certify that upon an Examination, in pursuance of the Law, entitled, "An Act making Provision for Officers, Soldiers, and Seamen, who have been disabled in the Service of the United States." Passed the 22d of April 1786, We do find that George Stansil residing in the State of New York—Aged twenty six years late a private in Cap. Cogh's (1) Company in the Regiment of Militia—Commanded by Colo. Jacob Klock and Claiming Relief under the act of Congress, recited in the said Law, as an Invalid in Fact; and that he became disabled in the Service of the United States, in Consequence of a wound and the shoulder on the 25th of Octob. 1781. And do further certify, that upon the Principles of the said Act of Congress, the said George Stansil is entitled to the Pay of Three Dollars per Month, Given under our Hands, in the City of Albany on the twenty second day of September in the Year of our Lord One Thousand Seven Hundred and Eighty-Six. George Stansil of the town of Canajoharie and County aforesaid being duly sworn deposeth and saith that he is the identical person mentioned and described in the original certificate hereunto annexed executed by Abrm. TenBroeck & Philip Schuyler bearing date on the twenty second day of September in the year of our Lord one thousand seven hundred and eighty six. (Signed) George Stansil (3)

Sworn and subscribed this 20th day of Apri(3)I 1824. Nathan Soule a judge of the court of Common Pleas in & for said county.

Reply to a letter of inquiry dated April 7, 1938

Reference is made to your letter relative to soldiers of the Revolutionary War, George Stansel, Henry J. Failing, Warner Dygert, Daniel Russell, born in 1737 in Wethersfield, Connecticut, married Anna Jones, resided in Columbia County, New York, and Bloomfield, New York, Palmer Holmes, and Zattew Payne.

Revolutionary War data furnished by this office are obtained from claims made to the United States for pension and bounty land based upon military service of soldiers in that war.

A careful search of the records fails to show such a claim on file on account of the services of Daniel Russell as described by you, or Henry J. Failing, Henry Failing, Warner Dygert, Palmer Holmes, or Zattew Payne, all spelling of the names searched.

The record of George Stansil is furnished you herein as found in the papers on file in the Revolutionary War claim for pension S.27536.

The date and place of birth, and the names of the parents of George Stansil are not shown. George Stansil enlisted, place not stated, and served as private in Captain Cogh's Company, Colonel Jacob Klock's New York Regiment, and on October 25, 1781, received a wound through his shoulder; length of service not stated.

He was allowed pension September 22, 1786 on account of disability resulting from said wound, at which date he was aged twenty-six years.

George Stansil was a resident of Canajoharie, Montgomery County, New York, in 1824. There are no family data.
